NOTICE is also hereby given that pursuant to Section 91 of the Companies Act, 2013 read with Rule 10 of the Companies (Management and Administration) Rules, 2014, the Register of Members and Share Transfer Books of the Company will remain closed from Saturday, 19<sup>th</sup> August, 2017 to Wednesday, 30<sup>th</sup> August, 2017 (both days inclusive) for the purpose of AGM and payment of dividend.

NOTICE is also hereby given that pursuant to Section 108 of the Companies Act, 2013, Rule 20 of the Companies (Management and Administration) Rules, 2014 (as amended) and Regulation 44 of SEBI (Listing Obligations & Disclosure Requirements) Regulations, 2015, the Company has provided to the Members the facility to cast their vote electronically through e-voting services provided by National Securities Depository Ltd. (NSDL) on all the resolutions set forth in the Notice of AGM.

The remote e-voting facility shall commence from Sunday, 27<sup>th</sup> August, 2017 at 9.00 a.m. and end on Tuesday, 29<sup>th</sup> August, 2017 at 5.00 p.m. The remote e-voting shall not be allowed beyond the said date and time.

A person whose name appears in the Register of Members/Beneficial owners as on the cut-off date i.e. 23<sup>rd</sup> August, 2017 shall be entitled to avail the facility of remote e-voting.

Any person who becomes member of the Company after despatch of the Notice of the meeting and holding shares as on the cut-off date i.e. 23<sup>rd</sup> August, 2017, may obtain the User ID and Password by sending a request at [evoting@nsdl.co.in](mailto:evoting@nsdl.co.in). The detailed procedure for obtaining User ID and Password is also provided in the Notice of the meeting which is available on Company's Website. Members who are already registered with NSDL for e-voting can use their existing User ID and Password for casting their vote through remote e-voting.

Members who have cast their vote by remote e-voting may attend the meeting but shall not be entitled to cast their vote once again. The Company shall provide Ballot facility at the meeting for members who attend the meeting and have not cast their vote earlier by any other means.
